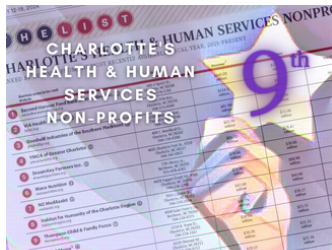

Family Stability

- Family Education achieved 99% client satisfaction, with 80% of families successfully completing classes in FY23/24
- Family Partners achieved 99% client satisfaction and 100% family Functioning gains.
- 100% of Foster Care parents and 99% of Foster Care youth expressed satisfaction, and 100% of Foster Care youth achieved mental health gains.
- 95% of School-Based Case Management clients expressed satisfaction and 100% reported being more confident in their ability to meet their child's & family's needs after participating in the program.
- 97% of Friends of the Children - Charlotte youth & caregivers expressed satisfaction. And 'Friend' Anthony Kyles participated in our 7th Changing Stories with Thompson podcast.



Mental Health

- 80% of families in Family Centered Therapy (FCT) achieved mental health gains and 100% of families expressed satisfaction with the program.
- School-Based Mental Health clients achieved 100% client satisfaction.
- 100% of Outpatient Therapy clients achieved mental health gains and expressed service satisfaction.
- 100% of Intensive In-Home (IIH) families reported getting better at handling daily life and related challenges.
- Wraparound achieved 93% Child and Family Team (CFT) satisfaction.
- 100% of youth in our eRTC program report that they feel better able to cope if things go wrong and 100% avoided or showed a reduction in number of behavior incidents from intake to discharge.
- 96% of stakeholders & youth in our Crisis Stabilization program reported satisfaction with the service.
